## Petroleum Membership

The dues shall be based on gallonage of all refined oils for the previous 12 month period, and is \$0.20 per 1,000 gallons, with a \$150.00 minimum and a \$2500.00 maximum. Retail outlet operators who own 2 or more stores shall pay \$100/store or \$0.20 per 1,000 gallons, whichever is greater.

Minimum dues are \$150.00 and maximum dues are \$2500.00. Please adjust your dues accordingly.

#### Petroleum Dues Amount

National Propane Gas Association Membership is based the number of bulk plants which you reported in a survey to NPGA. South Dakota Dues are based on gallonage. Please make sure to remit your association dues consistent with that reported number of bulk plants and the gallons of propane that you sell in South Dakota. Thank You!
