The dues shall be based on gallonage of all refined oils for the previous 12 month period, and is **\$0.20 per 1,000 gallons**, with a **\$150.00 minimum and a \$2500.00 maximum**. **Retail outlet operators who own 2 or more stores shall pay \$100/store or \$0.20 per 1,000 gallons, whichever is greater.**

Minimum dues are \$150.00 and maximum dues are \$2500.00. Please adjust your dues accordingly.

FYI: SDP2MA only retains a small portion of the propane dues. At the maximum (2 million gallons) the dues for SD are only \$530. The remainder (\$850) is required to be remitted to NPGA. (Minimum dues, \$700, SD keeps \$150 and remits \$550 to NPGA) Applies to all propane tables.
